WHAT WHAT DOES MOOMOO FINANCIAL INC. DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none">■ Social Security number and date of birth■ Address and contact information■ Assets, income, account balances and transaction history■ Risk tolerance
How?	All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons Moomoo Financial Inc. chooses to share; and whether you can limit this sharing.

What we do	
How does MoomooFinancial Inc. protect my personal information?	To protect your personal information from unauthorized access and use, we use a variety of measures designed to comply with federal law. Such measures include both proprietary and commercially available software and encryption programs. We also train our personnel on procedures and protocols to enhance protection against unauthorized access.
Why can't I limit all sharing?	Federal law only authorizes you to limit sharing with our affiliates and third parties. State laws and individual companies may give you additional rights to limit sharing. See below for more information
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
Joint marketing	An agreement between nonaffiliated financial companies that jointly market their services or products to consumers. Moomoo Financial Inc. does not engage in joint marketing with nonaffiliated companies.
Other important information	
<p>For California Residents. We will not share information we collect about you with nonaffiliated companies, except as permitted by law. For example, we may share information with you consent or to services your accounts. Among our affiliates, we will limit information sharing to the extent required by California law.</p> <p>For Vermont Residents. We will not share information we collect about you with nonaffiliated companies, except as permitted by law. For example, we may share information with your consent or to service your accounts. We will not share information about your creditworthiness without your authorization or consent, but we may share information about our transactions or experiences with you with our affiliates without your consent.</p>
